Case closed by Yellowstone County Attorney's office 8/11/16. Alpha House had an increase of 1 Substantiated Allegation of Inmate on Inmate Sexual Abuse as compared to 0 for 2015.

Substantiated Allegations:

Passages: Passages had a decrease of 1 substantiated allegation from 2015 to 2016. The ongoing investigation referenced in the 2015 annual report, resulted in a staff member's termination from employment. The county did not prosecute the case.
